## **ABOUT THE UNIVERSITY**


Middle Georgia State University (MGA) is the most affordable public state university in Georgia, enrolling more than 8,400 students in Fall 2020. Enrollment is largely comprised of students from most of Georgia's 159 counties, as well as students from across the U.S. and the world.

MGA has five campuses—Macon, Cochran, Dublin, Eastman, and Warner Robins, all located in central Georgia—and unlimited outreach through MGA Direct, a fully-online campus.

The **Macon Campus** is located in Bibb County near I-475. This 413-acre campus has a dozen major state-of-the-art buildings, a beautiful lake, and the Waddell Barnes Botanical Gardens. Located an hour south of Atlanta, the campus continues to grow, with a new residence hall that opened in August 2020 and an enrollment center scheduled to open in 2021.









MGA's 182-acre historic **Cochran Campus** in Bleckley County has a traditional quad, stately oaks, and a scenic lake. With MGA's largest concentration of student housing, the University's intercollegiate athletic program is based here. The campus also is home to the Georgia Academy for Math, Engineering, and Sciences, a program for highly motivated high school students.

The **Dublin Campus** extends the reach of the University into Laurens County and surrounding areas. The campus is a focal point for growth of health programs-particularly nursing.

The 22-acre **Eastman Campus**, a residential campus, is home to Georgia's only aviation school. Adjacent to the Heart of Georgia Regional airport, it offers flight training and aviation management programs. A fleet of 52 fixed-wing and rotary-wing aircraft support flight education here and at satellite locations in Macon and Adel.

#### **PEYTON T. ANDERSON ENROLLMENT CENTER**

Scheduled to open in 2021, the Enrollment Center, located on the Macon Campus, will serve students in the region as the enrollment hub for all five Middle Georgia State University campuses, providing concierge-style guidance for prospective students and their families.





The fifth MGA campus is located in **Warner Robins**. This 72-acre campus is just a half mile from the main gate of Robins Air Force Base in Houston County. The campus instruction supports bachelor's degrees in Nursing, IT, Business, and Early Childhood Education.

The University has six academic schools: Arts & Letters, Aviation, Business, Computing, Education & Behavioral Sciences, and Health & Natural Sciences.

A key area of planned growth is graduate programs, which currently include online master's degrees in information technology, management, teaching-secondary education, technical and professional writing, and nursing with emphasis on adult/gerontology acute care. A doctoral program in information technology is set to begin in Fall 2021. A Master of Science in Occupational Therapy is set to begin in 2022 (pending accreditation by the Southern Association of Colleges and Schools Commission on Colleges).

A member of the National Association of Intercollegiate Athletics, the MGA Knights compete in the Southern States Athletic Conference. The University fields teams in men's baseball, basketball, soccer, and tennis, and women's basketball, cross country, soccer, softball, tennis, and volleyball. The University also has club sports in football, cheer, and IHSA equestrian.

## THE OPPORTUNITY

The Vice President for University Advancement has a major role in positioning the institution for growth through highly effective fundraising and alumni relations. Reporting directly to the President, this senior officer is a member of the President's leadership team. The Vice President also serves as the Executive Director of Middle Georgia State University Foundation.

#### **RESPONSIBILITIES**

The Vice President for Advancement is responsible for directing an effective and cohesive division that currently has eight staff members, with the likelihood of expansion. The Vice President is the senior administrator for the Middle Georgia State University Foundation and the areas of Development and Alumni.

The Vice President interacts with all of the University's constituencies to implement and achieve the goals of the University's advancement efforts

and serves the Foundation Board and the Alumni Association. Using best practices in development, this senior officer coordinates closely with the President, Foundation Board members, Vice Presidents, Deans, and the Athletic Director, as well as works with the faculty, staff, and volunteers to ensure an organized approach to accomplishing the University's top strategic priorities.

The Vice President participates in the identification, solicitation, and stewardship of major gifts and is responsible for coordinating all athletic fundraising.



### Christopher R. L. Blake, Ph.D **MGA President**

Dr. Christopher R. L. Blake became president of Middle Georgia State on January 1, 2014. He worked with the campus community to articulate a new vision and values for the institution and to prepare the college for university status effective July 1, 2015.

Dr. Blake came to Middle Georgia State from Mount Mercy University in Cedar Rapids, Iowa, where he was president and professor of education for seven years. His earlier professional experience includes serving as provost and professor of education at Mount St. Mary's University, Maryland, where he developed new academic programs and oversaw strategic planning.

Dr. Blake's other career highlights include serving as associate dean of the College of Graduate Education and Research and associate professor of secondary education at Towson University, Maryland; senior lecturer in education at Brunel University, London; senior lecturer in education at West London Institute, London; and teacher of religious studies and social studies at Henry Box School, Oxford.

He holds bachelor's and master's degrees in Theology from the University of Oxford, Keble College; a post-graduate certificate in Education from Westminster College, Oxford; and a Ph.D. in Education from the University of London, King's College.

The Vice President sets ambitious, clear, and achievable goals, and inspires the Advancement staff to meet and exceed expectations.

The Vice President is active in the University and the surrounding communities and serves as one of the institution's representatives.

# REQUIREMENTS

A master's degree is required; a doctoral degree is preferred. Qualified candidates will have at least eight years of progressive development experience in higher education or a related area. The Vice President also will have:

- Significant leadership experience managing staffs and multiple responsibilities and projects through a collegial, team-building approach
- A thorough understanding of best practices in advancement services and fundraising, with demonstrated success with annual funds, major gifts, alumni relations, estate and planned gifts, corporate and foundation fundraising, and the management of volunteers
- A familiarity with IRS 990 Reporting
- The ability and confidence to develop and cultivate relationships with established and prospective donors, including the solicitation of seven-figure gifts
- A track record in planning and executing successful fundraising activities and campaign management, including goal setting, implementation of strategies, and identification of new donors
- The ability to develop a comprehensive and engaging alumni program that includes events, resources and services, publications, social media, and networking
- · An in-depth understanding of budgets and financial records associated with a comprehensive advancement program, including marketing and communications
- Excellent communication skills, oral and written
- The willingness and ability to travel as needed

### THE MGA FOUNDATION

Middle Georgia State University Foundation, Inc, is a non-profit corporation committed to stewardship, integrity, excellence, philanthropy, education, and advocacy on behalf of the University. The Foundation supports Middle Georgia State's mission by raising, investing, and distributing private dollars to help fund scholarships, classroom and campus enhancements, faculty programs, staff initiatives, capital needs, and collaborative community projects. As the cooperative partner of the University and a 501(c)(3) nonprofit organization, the Foundation is managed by a separate 19-volunteer member governing board.











#### **Macon-Bibb County, Georgia**

MGA's largest campus and administrative hub is located in Macon-Bibb County. Offering large-city amenities and true Southern charm, Macon-Bibb has a population of approximately 155,000, with the metropolitan area totaling almost 230,000.

Located 70 miles south of Atlanta, Macon is a popular tourist destination. Macon-Bibb is rich with cultural assets such as the Hay House, Tubman Museum, and

Ocmulgee Monument Historic National Park, a lively arts scene, annual festivals, including the International Cherry Blossom Festival, and a well-versed music heritage, playing home to such greats as Otis Redding, Little Richard, and the Allman Brothers Band.

Most recently, Macon has become a go-to location for movie/TV filmmaking. Served by three hospitals, Macon is one of Georgia's major medical service centers. Just 16 miles south of Macon-Bibb is Robins Air Force Base, the largest single-site industrial complex in Georgia.
